

BOARD MINUTES
Rising Sun-Ohio County Community School Corporation
March 8, 2022

The regular session of the Board of School Trustees was held as advertised on March 8, 2022 at 7:30 P.M. in the administration building. Members present were Gary Kinnett, Connie Smith, Andrea Kirkpatrick, Renee Cole, Corey Potts and Superintendent Branden Roeder. Also present was Beth Terrill.

Meeting began with the Pledge of Allegiance.

Upon motion by Connie Smith and seconded by Gary Kinnett to approve the agenda as presented, members voted as follows: Aye – Connie Smith, Gary Kinnett, Renee Cole, Corey Potts and Andrea Kirkpatrick.
