

BOARD MINUTES
Rising Sun-Ohio County Community School Corporation
July 19, 2022

The regular session of the Board of School Trustees was held as advertised on July 19, 2022 at 6:32 P.M. in the administration building. Members present were Gary Kinnett, Connie Smith, Andrea Kirkpatrick, Renee Cole, and Superintendent Branden Roeder. Also present was Beth Terrill.

Meeting began with the Pledge of Allegiance.

Connie Smith made a motion to adopt the agenda as presented, and it was seconded by Renee Cole. Members voted as follows: Aye – Connie Smith, Andrea Kirkpatrick, Gary Kinnett, and Renee Cole.

There were no public comments.

The minutes for the June 21, 2022 meeting were reviewed. Upon motion by Andrea Kirkpatrick and seconded by Connie Smith to approve the minutes as presented, members voted as follows: Aye – Andrea Kirkpatrick, Renee Cole, Gary Kinnett, and Connie Smith..

Mr. Roeder recommended accepting resignations from Jane Angst, high school athletic secretary and Lucy Carrigan, middle school 7th grade boys' basketball coach. Mr. Roeder recommended Taylor Bruce, Samantha Craig, Rebekah Caddell, and Nicole Becker as paraprofessionals. Upon motion by Renee Cole and seconded by Andrea Kirkpatrick, members voted as follows: Aye – Gary Kinnett, Renee Cole, Connie Smith and Andrea Kirkpatrick.

Mr. Roeder recommended raising the camp/latchkey salary 15 cents an hour for teachers who worked 100 hours/year. This is retroactive to the beginning of June 2022. Corey Potts arrived at the meeting.

Mr. Roeder recommended a supplemental contract of \$1,000.00 a year to the teacher who instructs a certain homebound student. Upon motion by Renee Cole and seconded by Connie Smith to approve the recommendation, members voted as follows: Renee Cole, Connie Smith, Corey Potts, Gary Kinnett, and Andrea Kirkpatrick.

Mr. Roeder opened the only sealed bid for the sale of Mid Bus #5. Mr. Roeder recommended selling it to Jason Salisbury as is. Upon motion by Connie Smith and seconded by Andrea Kirkpatrick, members voted as follows: Aye – Corey Potts, Connie Smith, Renee Cole, Gary Kinnett, and Andrea Kirkpatrick.
