

BOARD MINUTES  
Rising Sun-Ohio County Community School Corporation  
November 8, 2022

The regular session of the Board of School Trustees was held as advertised on November 8, 2022 at 5:30 P.M. in the RSHS library. Members present were Gary Kinnett, Connie Smith, Andrea Kirkpatrick, Renee Cole, Corey Potts and Superintendent Branden Roeder. Beth Terrill, and Noel Bostic were also present.

Meeting began with the Pledge of Allegiance.

Connie Smith made a motion to adopt the agenda as presented, and it was seconded by Andrea Kirkpatrick. Members voted as follows: Aye – Connie Smith, Andrea Kirkpatrick, Gary Kinnett, Corey Potts and Renee Cole.

There were no public comments.
